Thai Enquirer News Summary

#### **Political News**

- The Supreme Court's Criminal Division for Holders of Political Positions has dropped a
  case against former Prime Minister Yingluck Shinawatra, who was accused of abusing her
  power by transferring Thawil Pliansri from his position as the secretary-general of the
  National Security Council to an adviser to the prime minister during her administration in
  2011.
  - Thawil argued that the move was legitimate and the case was filed by the Office of the Attorney General, which asserted that the transfer constituted an abuse of power in violation of Section 157 of the Criminal Code and the Anti-Corruption Act.
  - ❖ The court concluded that there was no evidence indicating Yingluck's interference with the transfer. It determined that the transfer adhered to regulations and found

no proof that it was intended to cause harm to Thawil. Consequently, the arrest warrant against her in this case is no longer valid.





- Prime Minister Srettha Thavisin commented on his nickname "Salesman Stand Shin," stating that today he is the real Prime Minister and is committed to completing the 4-year term.
  - Regarding the "Kaeng Som Pak Ruam" nickname for his government, he responded that the government is a mixture of sour, sweet, salty, and spicy flavors from various political factions. He said all ministers are fully prepared to work. The reason the government did not include the Move Forward Party was because the party could not gather enough votes to beat the Senate.
- Yesterday the Thai press has assigned nicknames to the government and members of the cabinet. Some examples include:
  - ♦ Pheu Thai-led government = Kaeng Som Pak Ruam (แกงสัมผลักรวม) symbolizing the Pheu Thai Party's formation of the government that excludes the winning party, the Move Forward Party, in order to include junta-backed parties.
  - ❖ Prime Minister Srettha Thavisin = Salesman Stand Shin (เซลส์แมนสแตนด์ชิน) referring to the prime minister as a stand-in for the Shinawatra family.
  - Deputy Prime Minister Phumtham Wechayachai = Long Kong (དธิปุกติปฺ) likening the deputy prime minister to a langsat plant with big branches and abundant fruits, symbolizing the many issues Phumtham oversees while Srettha is abroad.
  - ❖ Defence Minister Sutin Klungsang = Plick Tin Su Dao (พลิกทินสู่คาว) symbolizing his unexpected appointment as the defense minister.
  - ❖ Justice Minister Tawee Sodsong = Tawee Sord-Sai (ทวี สอดใส้) symbolizing his anticipated appointment as the justice minister and his responsibility to oversee issues related to the incarceration of former Prime Minister Thaksin Shinawatra.

- ♦ Deputy Interior Minister Chada Thaiseth = Mafia La-Hei-Jai (มาเฟียละเพียง) highlighting his background as a former mafia figure who later became in charge of cracking down on mafia figures across the country until the arrest of his son-in-law, accused of extortion by the police, not his task force.
- Sentence of the year = "I will work tirelessly," uttered by Prime Minister Srettha upon taking office, and indeed, he has lived up to his promise, working tirelessly over the past three months.
- The Office of the National Anti-Corruption Commission (NACC) has announced the scheduled disclosure of assets and liabilities for 13 political officeholders on December 28.
  - ❖ Among those whose assets and liabilities will be disclosed are:
    - Srettha Thavisin, Prime Minister and Minister of Finance, who assumed office on September 5, 2023.
    - ➤ Gen Prawit Wongsuwan, former President of the Sports Authority of Thailand, who left office on September 1, 2023.



• Senator Somchai Sawang-Karn shed doubt on the Department of Corrections' decision to extend hospital stay for inmate former Prime Minister Thaksin Shinawatra after discussing with representatives from the department.

- Somchai argued that Thaksin's medical diagnoses could not justify his extended stay in his opinion because Thaksin's illnesses only include common ailments, such as high blood pressure, coronary artery disease, previous COVID-19 lung infection, and osteoporosis.
- Somchai also revealed that the Department of Corrections failed to comply with its own regulations regarding inmate care. These regulations stipulate that two caregivers must be on guard at the hospital room per shift and take a photo of the inmate every two hours. However, the department did not follow these regulations in Thaksin's case, Somchai said.



- Deputy Prime Minister Somsak Thepsuthin has criticized the Department of Corrections, holding it responsible for the lack of transparency in the detention of former Prime Minister Thaksin Shinawatra. He attributes this issue to the department's leadership, asserting that it comprises individuals with influential connections rather than competent professionals.
  - ❖ Thaksin has been held at the Police General Hospital for over 120 days. For an extension of his detention, medical recommendations and approvals from the chief of the Bangkok Remand Prison, the director of the Department of Corrections, and the justice minister are required.
  - ❖ Justice Minister Tawee Sodsong stated that no such request has been forwarded to him by the Department of Corrections.
  - As a former justice minister, Somsak contends that the department's leadership struggles to address basic inquiries due to a lack of understanding of regulations. He attributes this deficiency to their promotions based on connections rather than merit. Somsak emphasizes the importance of adhering to rules and proper procedures without fear.
- Senator Somchai has aired opposition to the proposition of writing a new charter, saying it will not be worth spending 10.5 billion Baht on conducting related public referendums.

- Speaking at a Senate meeting on Tuesday, Somchai argued against the need for a new charter, saying that the current Constitution had already garnered 16 million votes in a previous public referendum.
- ❖ According to Somchai, the process of drafting and enacting a new constitution would necessitate three separate public referendums, each incurring a cost of approximately 3.5 billion baht, which will add up to 10.5 billion baht. These estimated costs do not include the salaries of some 475,000 officials, compensation for members of the new Constitution Drafting Assembly and payments for their support staff.
- ❖ Factoring in these expenses, Somchai said another 15.7 million baht or more would be needed.
- ❖ While campaigning for votes, Pheu Thai had promised to enact a fully democratic people's charter. It also promised to keep the first two chapters on the type of government and monarchy untouched. However, Somchai contends that 27 other articles in other chapters refer to the power of the King, so it would be impossible to draft a new charter without touching on royal powers.
- The main opposition Move Forward Party (MFP) urged the government to revise the question in the first referendum for the rewriting of the charter.
  - ❖ The committee responsible for designing the referendums on the charter's rewrite is proposing three referendums. The proposals are scheduled to be presented to the Cabinet within January.
  - ❖ The question for the first referendum is, 'Do you agree that the charter should be rewritten without amending Sections 1 and 2, which are related to Thailand's sovereignty and the power of the monarch, or not?'
  - ❖ MFP spokesperson Parit Wacharasindhu said the question is too specific. He said the question will make it hard for people who agree with the rewriting but do not agree that Sections 1 and 2 should be left untouched to vote that they agree with the question.
  - ❖ If they vote that they do not agree with the question because they believe that Sections 1 and 2 should also be amended, they will be included in the group who do not agree that the charter should be rewritten, which would increase the chance that the rewriting will not happen at all. So this will force them to vote yes if they want to see a rewriting even though they do not agree that Sections 1 and 2 should be left untouched.

- PM Srettha Thavisin travelled to Narathiwat to get a first-hand look at the floods ravaging at least five provinces in the far South. He made a stop in Chana district where he said large areas in the southernmost provinces were devastated by the flash floods caused by a lingering low-pressure system. He was told by authorities that the floods were easing as water was being drained into the sea. However, damage to properties was visible.
  - ❖ After Narathiwat, the premier travelled on to Phuket where he met his Malaysian counterpart, Anwar Ibrahim, over dinner at 6pm on Tuesday. The Malaysian leader is in Phuket on a private visit.





## **Economic News**

- Tensions flared at the Cabinet meeting yesterday as disagreement emerged over the composition of a committee tasked with reviewing the Budget Bill for the 2024 fiscal year. The Budget Bureau submitted a proposal listing five members to scrutinize the bill during its Parliamentary review scheduled for January 3-5, 2024.
  - \* The proposed committee included:
    - Phumtham Wechayachai, Deputy Prime Minister and Minister of Commerce
    - ➤ Julapun Amornvivat, Deputy Minister of Finance
    - Monphon Charoensri, Deputy Minister of Transport
    - > Chakkraphong Saengmanee, Deputy Minister of Foreign Affairs
    - Chalermphol Pensoot, Director of the Budget Bureau
  - ❖ However, the suggested composition sparked immediate objection from Anutin Charnvirakul, Deputy Prime Minister and Minister of Interior, representing the Bhumjaithai Party. Anutin argued that the five names did not proportionally represent the 18 ministers within the coalition government, particularly from his party.

- ❖ In an attempt to bridge the divide, PM Srettha Thavisin proposed reviewing the committee in the nex Cabinet meeting to ensure all 18 ministers have input into the final composition.
- Yesterday the Cabinet has approved the draft bill for the fiscal 2024 budget, amounting to 3.48 trillion Baht, and the bill will be presented to Parliament for its first readings between January 3 and 4, said Prime Minister Srettha Thavisin. If the bill successfully passes all readings, the budget is anticipated to be submitted for royal endorsement on April 17.
  - ❖ The fiscal 2024 budget is 9%, or 295 billion Baht, higher than the fiscal 2023 budget of 3.185 trillion Baht. The fixed budget has been set at 2.535 trillion Baht, constituting around 73% of the total budget. The investment budget is 715.4 billion Baht, making up approximately 21% of the budget. The budget deficit is projected to be 693 billion Baht, equivalent to 3.6% of the total budget. This represents a reduction of 2 billion baht compared to the fiscal 2023 budget deficit of 695 billion Baht.
  - ❖ The estimated income is 2.787 trillion Baht, with a corresponding estimated GDP of 19.02 trillion Baht.
- The Cabinet approved the Ministry of Finance's measures to extend the reductions in the transfer fee for residential properties valued at less than 3 million Baht from 2% to 1% and the mortgage fee from 1% to 0.01% until the end of 2024.
  - This adjustment is expected to result in a decrease in state income by approximately billion Baht. Nevertheless, it is anticipated to stimulate economic growth, contributing to a projected increase in GDP by 0.5%.
  - ❖ The Cabinet also approved the tripartite wage committee's decision to increase the daily minimum wage by 2 to 16 Baht, from 328-354 per day to 330-370 per day, effective on January 1, according to Labor Minister Phipat Ratchakitprakarn.
  - The rates vary from province to province based on their outputs, with the highest at 370 Baht per day in Phuket and 330 Baht per day in the three southernmost provinces of Yala, Pattani, and Narathiwat. The rate in Bangkok, Nakhon Pathom, Nonthaburi, Pathum Thani, Samut Prakan, and Samut Sakhon will increase from 353 Baht per day to 363 Baht per day.
  - ❖ The government is pushing for the next hike in March. The Pheu Thai Party has promised to increase the minimum wage to 400 Baht per day as soon as possible and 600 Baht within four years.

- The Energy Regulatory Commission (ERC) lifted PTT Plc's (PTT) objection to a previously imposed penalty and ordered the state-owned enterprise to pay 4.3 billion Baht in shortfall fees. This decision stems from PTT's failure to deliver natural gas according to the terms of its sales agreement.
  - ❖ The shortfall penalty will be used to directly benefit consumers by reducing natural gas prices, consequently lowering electricity prices for the January-April 2024 period to 4.20 Baht per unit as previously approved by the Cabinet.
  - ❖ Krungsri Capital Securities analysts weighed in on the impact of this ruling, stating that the 4.3 billion Baht penalty represents a downside for PTT, potentially reducing its normal profits by 3.3%. This figure also factors in the previously announced gas price structure adjustment, which is expected to increase PTT's operational costs. According to the firm's estimates, every 1 billion Baht in cost increment translates to a roughly 0.8% drop in PTT's profits.
- Yesterday, 30 representatives of minority shareholders in Nusasiri Plc (NUSA) filed a complaint with the Department of Special Investigation (DSI), accusing the NUSA board of directors of conducting a massive asset sale without proper notification or consent from shareholders.
  - ❖ The shareholders claimed that the board approved the sale of assets worth 110 billion Baht, roughly 70% of NUSA's total valuation of 160 billion Baht, without convening a meeting to inform or seek approval from minority shareholders. This raised concerns about possible ulterior motives. The complaint further asserted that the sale potentially breaches the Securities and Exchange Act of 1992.



 Bangkok Dusit Medical Services (BDMS) President and CEO, Poramaporn Prasarttong-Osoth, purchased 997.5 million Baht worth of BDMS shares last week. Poramaporn, the daughter of BDMS co-founder Prasert, and the heir to the Prasarttong-Osoth legacy, acquired a total of 38 million shares at an average price of 26.25 Baht per share. This substantial transaction took place on December 22 through Kiatnakin Phatra Securities, as reported by the Stock Exchange of Thailand.

- ❖ As a result of this transaction, Poramaporn's holdings of BDMS shares increased from 823,879,810 shares (5.18%) to 861,879,810 shares (5.42%).
- ❖ BDMS shares began the year around 28.5 Baht. Yesterday they saw a closing price of 27.50 Baht (up 0.75 Baht), with a trading value of 1.7 billion Baht.

- Deputy Director-General of the Government Public Relations Department, Sudruetai Lertkasem, has been appointed as the new Director-General of the department following the departure of Lt. Gen. Sansern Kaewkamnerd, who retired on September 30.
  - ❖ The department's outlets include the National Broadcasting Services of Thailand, NBT World, and Radio Thailand.

- That new business registrations maintained positive momentum in November 2023. The Department of Business Development (DBD) reported positive figures across new registrations, registered capital, and year-to-date comparisons.
  - ❖ According to the DBD, 5,979 new businesses registered in November 2023, representing a 4% increase compared to the same period in 2022. Total registered capital for new businesses reached 25.27 billion Baht, reflecting a significant 33.83% increase year-over-year.
  - ❖ Over the first 11 months of 2023, a total of 81,291 new businesses were registered, marking a 12.16% increase compared to the same period in 2022. Total registered capital for new businesses in the first 11 months reached 546.85 billion Baht, representing a robust 33.83% increase year-over-year.'
  - ❖ On the other hand, 2,608 businesses ceased operations in November 2023, showing a 3% decrease compared to the same period last year. The total registered capital for these businesses over the first 11 months was 17.37 billion Baht.
  - ❖ The total number of ceased businesses during the first 11 months was 17,858, representing a 10.95% increase compared to the same period in 2022. The total registered capital for ceased businesses over the first 11 months was 107.72 billion Baht, indicating a modest 2.62% increase compared to the same period in 2022.
  - ❖ The DBD forecast that the overall number of new business registrations in 2023 is expected to range between 84,000 and 86,000, with a total registered capital of 550 to 600 billion Baht.
