#### **Thai Enquirer News Summary**

#### **Economic News**

• Niwatchai Kasemmongkol, secretary-general of the National Anti-Corruption Commission (NACC), denied reports that the NACC has already provided objections and recommendations on the 10,000 Baht digital wallet policy to the government.



❖ Leaked reports from the National Anti-Corruption Commission (NACC) shows that the handout that the government is planning is in violation of many things such as the way it is to be issued and also the country is not in crisis yet.

➤ The country is not in crisis such as those seen in 1997 (Tom Yum Krung financial crisis), Hamburger crisis in 2008/2009 nor the 2011 flooding seen in Thailand or the recently passed economic crisis created due to outbreak of Covid-19.



- ❖ The 177 pages of study by the NACC says that 2024 is not a crisis and therefore there is no need to distribute the funds yet.
- \* According to news reports, the 8-point recommendations by the NACC includes:
  - > The government should ensure that the implementation of the policy does not favor a political party, an individual, or a specific group, especially large corporations or those who are not economically disadvantaged.
  - The details on the policy presented by the Pheu Thai Party before the May 2023 election differ from those announced in Parliament in September 2023. The Election Commission should investigate these differences to prevent political parties from making conflicting promises before and after elections.
  - ➤ Current economic indicators suggest that the economy is not in crisis but is slowing down. Measures to stimulate the economy should consider factors such as private consumption, the unemployment rate, public spending, and the reskilling of laborers.
  - ➤ The implementation of the digital wallet policy must consider costeffectiveness, the necessity for economic stimulation, and the impact on financial stability. Adhering to principles of transparency, checks and

balances, fiscal integrity, and flexibility is crucial. The project has more cons than pros, requiring 500 billion Baht for implementation with an economic multiplier of only 0.4. The government and the people would be burdened with the debt incurred by the policy for 4-5 years, impacting government spending.

- The government must ensure that the implementation of the policy complies with the state financial discipline law and the charter.
- The government should assess risks associated with policy implementation and develop measures to manage negative impacts, prevent corruption, and monitor spending before, during, and after implementation.
- The policy should target the most vulnerable groups in society, such as people living below the poverty line.
- The use of blockchain technology in managing the policy's implementation should consider its necessity and the time needed to develop a system backed by the technology. They recommend the government use the Pao Tang application.



- The uncertainties about the recommendations by the NACC, which has not arrived in the hands of the government, prompted Deputy Prime Minister Phumtham Wechayachai to push out the meeting of the government's committee on the policy as the committed awaited the upcoming report on the policy from the NACC.
  - ❖ Deputy Prime Minister Phumtham, meanwhile, stated that the NACC's recommendations on the digital wallet scheme will be sent to the government's committee within the next one or two weeks. He also called on reporters to avoid making speculative claims about the scheme.






- The cabinet agreed to cut the excise tax on diesel by one Baht per litre for 3-months, effective January 20 until April 19.
  - ❖ Deputy Finance Minister Julapun Amornvivat said that the tax cut will help ease the financial burden on consumers, but will cost the state about 6 billion Baht in revenue loss over the three-month period. The government will try to manage energy prices in line with global oil prices and in a way that it will not place too much of a burden on the national budget in the long term.
  - ❖ The cabinet also approved, in principle, the frameworks for the fiscal 2025 budget. The proposed budget is 3.6 trillion Baht, with a budget deficit of 713 billion Baht. This marks an increase compared to the 2024 proposed fiscal budget of 3.48 trillion Baht, which had a budget deficit of 693 billion Baht.
  - ❖ For reference, the fiscal 2023 budget was 3.19 trillion Baht, accompanied by a budget deficit of 695 billion Baht.
- The Stock Exchange of Thailand (SET) index continued its descent yesterday, closing at 1,401.72 points, down 5.30 points (-0.38%) amidst a trading value of 39.47 billion Baht. A confluence of domestic factors drove the decline, dampening investor sentiment.
  - Analysts attributed the broader market underperformance to the persistent interest rate differential, which continues to fuel fund outflows. Large-cap retail stocks, including CPALL, CPN, and COM7, faced particular pressure as investors factored in potential delays or downsizing of the government's planned digital wallet policy. Today's ITD bondholders' meeting remains in focus, with the market awaiting potential market-moving outcomes.

- Italian-Thai Development Plc (ITD) will hold its 1/2024 bondholders' meeting today via an online meeting platform to address debt-related issues after the company previously requested a two-year expansion of its debenture payment.
  - The meeting reportedly has key agenda items on the table:
    - Consider relaxing the D/E Ratio.
    - > ITD proposes a two-year extension for its debentures payment in exchange for a higher interest rate.
  - ❖ Yesterday, ITD stock briefly touched a high of 0.74 Baht before closing at 0.73 Baht, a gain of 0.03 Baht (4.29%). The positive movement reflects investor optimism regarding a potentially favorable outcome from today bondholders' meeting.
- Thai Union Group Plc (TU) announced plans to withdraw its investment in Red Lobster Master Holdings, L.P. (RLMH) through its subsidiary Thai Union Investment North America LLC (TUINA). The decision, disclosed at the company's recent board meeting, comes after Red Lobster's business faced multiple headwinds from the COVID-19 pandemic, industry challenges, rising interest rates, and cost pressures.
  - Thai Union has been a Red Lobster investor since 2016. The divestment will result in a one-time non-cash impairment charge of 18.5 billion Baht in Q4 2023, which could potentially affect Thai Union's interest payments and potential dividend payouts. The company plans to negotiate these issues with bondholders before February's financial results announcement.
  - ❖ To counterbalance the divestment's financial impact, Thai Union's board also approved a share buyback program with a budget of up to 3.6 billion Baht, covering up to 200 million shares. The program will run from February 20 to June 30, 2024.



#### **Political News**

- The Constitutional Court is poised to deliver a highly anticipated verdict today in the case against former Transport Minister, Saksayam Chidchob, who is accused of violating Article 170(5) of the Constitution, by allegedly failing to relinquish his stake in Buri Charoen Construction upon assuming ministerial office.
  - ❖ On the D-day for the decision of the Constitutional Court against Saksyam Chidchob, if found guilty there is a possibility of the Bhumjai Thai party being dissolved. The reason for the possible dissolution is that Supawat (the person who is in the so called nominee of the share transfer case) is also a big doner to Bhumjai Thai party.
  - ❖ Ahead of the verdict, the Constitutional Court has implemented heightened security measures around its premises due to concerns over potential disruptions from gatherings.



• The Senate is poised to submit a petition for a general debate on the implementation of government policies on January 22, after having gathered 98 signatures for the petition submission.

- ❖ According to Senator Seri Suwanphanon, the deadline for senators to endorse the petition is until the morning of January 22. Although the required number of signatures is 84, Seri expressed confidence that no one would withdraw their endorsement.
- ❖ The Senate is activating Section 153 of the charter to propose a motion for a general debate against the government, without the requirement for a resolution to be passed. Senator Seri emphasized that the government's lack of concrete outcomes on various issues over the past four months justifies this action. The subjects to be addressed in the debate encompass the incarceration of former Prime Minister Thaksin Shinawatra and the government's 10,000 Baht digital wallet policy.
- ❖ The current assembly of junta-appointed Senators refrained from utilizing this section against the previous Prayut administration throughout the preceding four years. Senator Seri asserted that Prime Minister Srettha Thavisin should personally furnish responses to the Senate, deeming it advantageous for the government.



- Meanwhile the opposition is considering whether to launch its first no-confidence or general debate against the government at the end of March or early April. An opposition whips' meeting on Tuesday discussed the issue, said Parit Wacharasindhu, a Move Forward Party spokesman.
  - ❖ While a general debate does not affect the government's survival, enough noconfidence votes would sink it.
  - ❖ He said the opposition, led by Move Forward, intends to use parliamentary means to keep the administration in check by pressing for an explanation of the cost-effectiveness and transparency of key government projects. The opposition is particularly critical of the flagship digital wallet scheme and the 1-trillion-Baht Land Bridge megaproject.
  - ❖ Parit also denied his party was skirting the controversy surrounding jailed former premier Thaksin Shinawatra's hospital stay.



- The Department of Corrections has asked people not to refer to former prime minister Thaksin Shinawatra as a prison inmate, to smooth his future return to society even though he is serving a jail sentence while in hospital.
  - ❖ The request was made in a press release. There was no attributed spokesman in the press release either. The statement said the department referred to male and female offenders as inmates only when they were actually in prison. This practice was in compliance with the Corrections Act. The word inmate should not be used when inmates' names were mentioned outside prison. Doing so could affect their return to society and also infringe on their human rights, the statement said.
  - The honorifies Mr, Mrs and Miss were used in medical records of when they were taken to external hospitals for treatment, the department said. Referring to them as Inmates could brand them for life, as the reference would remain in social media systems for a long time.
- The leader of the Democrat Party, Chalermchai Sri-on, has vehemently denied any involvement in a major pork smuggling scandal. He suggests that those attempting to link him to the scandal may have political motivations.
  - Chalermchai, a former agriculture minister in the Prayut administration, responded to reports that one of the four suspects pursued by the Department of Special Investigation, businessman Li Shengjiao, is his half-brother.
  - The Criminal Court has issued arrest warrants for Li and three other defendants for allegedly smuggling over 10,000 shipping containers of pork valued at approximately 6-7 billion Baht. The charges include tax evasion, Customs Act violations related to the import of animals and carcasses, and money laundering.
  - ❖ While Chalermchai acknowledges a family tie with Li, he denies sharing the same father. He also asserts that he was not responsible for pork smuggling cases during his tenure, passing the responsibility to former Deputy Agriculture and Cooperatives Minister Prapat Pothasuthon.

- Chalermchai claims that his involvement in pork-related issues primarily focused on disease outbreaks, and his tenure resulted in the confiscation of over a million kilograms of smuggled pork.
- ❖ In response to a former Democrat member, Kanchanee Walayasevi, who tried to connect him to another wanted suspect, Wu Enhui, by posting a photo of him meeting Wu in China, Chalermchai simply stated that Kanchanee was being foolish. He also criticized her efforts to link their relationship, emphasizing that such actions could damage international relations and discourage potential investors.





- The charges against 2 former ministers and 2 high-ranking officials from the Ministry of Labour for alleged bribery were not aimed at discrediting anyone, said Justice Minister Tawee Sodsong.
  - ❖ His comments came after former Labour Minister Suchart Chomklin denied his involvement in the bribery. He suggested that the charges might be politically motivated, claiming they have adversely affected his reputation. Furthermore, he mentioned the possibility of countersuing the Department of Special Investigation if the National Anti-Corruption Commission deems that he was not involved.
  - ❖ The alleged bribery case involves the exchange of approximately 36 million Baht for a green light to send about 12,000 Thai workers to Finland between 2020 and 2023. The ministers and officials are accused of demanding 3,000 Baht from a Thai recruitment company for each worker sent for wild berry picking in Finland. Some of the workers who went there legitimately also became victims of human trafficking.
  - ❖ Suchart stated that his involvement in the process of sending Thai workers to Finland typically begins between June and July. He assumed office in August 2020 and claimed that for 2021 and 2022, he followed regulations, asserting that the ministry was not involved in the worker selection process.



- The cabinet has approved the extension of the emergency decree in the 3 southernmost provinces from January 20 until April 19.
  - As part of this extension, the decree will be lifted in two districts, namely the Panare District in Pattani and the Raman District in Yala, due to an improvement in the security conditions, characterized by a reduction in insurgent attacks. Subsequently, the decree will be replaced by the National Security Act.
  - ❖ This adjustment will result in a decrease in the number of districts where the emergency decree is in effect, reducing the total from 33 districts, as initially invoked in July 2005, to 18 districts.
- Laong Tiyapairat and Nanat Hongchuvech from the Pheu Thai Party have officially been appointed as Members of Parliament (MPs), as published in the Royal Gazette.
  - ❖ Laong and Nanat, positioned 32<sup>nd</sup> and 33<sup>rd</sup>, respectively, on the Pheu Thai's party list, have been elevated to fill the vacant seats following the resignations of Minister of Digital Economy and Society Prasert Chantararuangthong and Deputy Prime Minister Somsak Thepsuthin from their MP positions on January 15, 2024.
  - ❖ Prasert and Somsak had previously stated that they voluntarily relinquished their MP positions to fully focus on their duties, allowing young Pheu Thai party members an opportunity to gain experience in Parliament.





#### **General News**

- Hot & Cold
  - ❖ Metrological department says that from today onwards temperature is set to fall to as low as 20 degrees for a period of 3-days until January 19<sup>th</sup>. Temperatures have been in excess of 33 degrees in the afternoon for weeks.



- The Appeals Court changed the prison term imposed on a non-commissioned police officer from just 1-year and 15 days to 10-years and 2-months for crashing his big bike into an eye doctor while she was using a zebra crossing in Bangkok's Phaya Thai district in January 2022. The sentence was then commuted to five years.
  - ❖ Both individuals were injured in the accident, but Dr. Waraluck Supawatjariyakul, who worked at Rajavithi Hospital, died upon arrival at the hospital.
  - ❖ On April 25, 2022, the Criminal Court sentenced Pol Lance Corporal Norawit Buadok, a crowd control officer attached to the Metropolitan Police Bureau, to one year and 15 days without suspension, after finding him guilty of speeding and reckless driving, among other offenses.
  - The prosecutor appealed the sentence, demanding higher penalties for the defendant, who also appealed for the prison term to be suspended.





- Foreign Minister Parnpree Bahiddha-Nukara expressed disagreement with the Israel Embassy in Thailand's decision to display photos of hostages abducted by Hamas on the back of Tuk Tuks in Bangkok. He is concerned that this move could jeopardize negotiations for the release of the remaining 8 Thai hostages.
  - ❖ The minister stated that he has contacted Israel's ambassador to Thailand, Orna Sagiv, to discuss the issue, emphasizing that the embassy did not consult the ministry before launching the campaign.
  - ❖ He underscored that Thailand considers itself a friend to every country, with the safe return of the Thai hostages being the top priority. He expressed a desire for countries not to exploit Thailand for creating conflicts.





- A police officer, who is the father of one of the 5 youths allegedly involved in the killing of a woman with a mental disability in Sa Kaeo, has been transferred to an inactive post following a scapegoat allegation in the murder case.
  - ❖ Five youths aged between 13 and 16 became suspects when CCTV footage captured them attacking 47-year-old Buaphan Tansu in front of a 7-Eleven store in Aranyaprathet District on the night of January 11.
  - After the attack, they left the scene with her unconscious body on one of their two motorcycles before she was found dead in a pond next to a school in the district.
  - ❖ The police initially arrested Buaphan's husband, Panya, aged 54, who confessed to the killing. However, he was later released after CCTV footage recovered by Channel 8 was released to the public. Panya told reporters after his release that he was not forced to confess; people were accusing him of the murder, and he was confused, so he just wanted the issue to be over with.
  - Nevertheless, Sa Kaeo Police Chief Pol Maj Gen Omsin Boonyanuson said that a deputy inspector at Aranyaprathet Police Station has been transferred to an inactive

post at the Sa Kaeo police headquarters to avoid interference in the investigation since his son was implicated in the murder. The five youths are now in custody.

- ❖ Pol Maj Gen Omsin promised a fair and transparent investigation.
- ❖ Last night, Deputy National Police Chief Surachet Hakphal arrived at the Sa Kaeo police headquarters to follow up on the case. He will personally interview the deceased's husband to seek truth in the scapegoat allegation.





- Meanwhile netizens are criticising Aranyaprathet police station in Sa Kaeo province for its investigation into the murder of a 47-year-old local women, after a recent development revealed that the arrested suspect, her husband, could be a scapegoat.
  - ❖ The hashtag #ป้าบัวผัน (Aunty Buaphan) was trending on Thailand's X (formerly twitter) on Tuesday, with nearly 750,000 mentions.



- A TikTok user, @wannabnailssalon, posted a video of a small snake on a plane heading from Bangkok to Phuket.
  - ❖ After passengers pointed out the snake, a flight attendant used a plastic bottle and a bag to catch it before landing. The incident occurred on Thai AirAsia's FD3015 flight departing from Don Muang Airport to Phuket Airport on January 13.
  - As of now, there is still no report on how the snake managed to get on the plane, as no passenger has admitted to bringing it on board.

- January 17<sup>th</sup> 2024 The Constitutional Court has also set the date of January 17<sup>th</sup> 2024 as the date to look into the case of false asset declaration and other allegations made against the former Minister of Transport Saksayam Chidchob.
- January 17, 2024 The Criminal Court is set to read out the verdict against 29 former co-leaders of the People's Alliance for Democracy after many defendants, including Chamlong Srimuang, fell ill on December 18<sup>th</sup> verdict day. They are accused of shutting down the 2 main airports in Bangkok during their protest in December 2008.

- January 24, 2024 The Constitutional Court would announce its verdict in the iTV shareholding case against former Move Forward Party leader Pita Limjaroenrat.
- January 31, 2024 The Constitutional Court would announce its verdict in the case of Move Forward party using Article 112 as a campaign issue, but the decision would have a major impact on Move Forward party immediately.
- January 31, 2024 Defense Minister Suthin Klangsaeng says that it is the deadline for Thailand to make a decision on the planned purchase of the 3 submarines from China.
- February 7, 2024 Monetary Policy Committee holds its meeting.
- February 20, 2024 The National Economic & Social Development Council (NESDC) is set to announce the Q4 2023 GDP data that could possibly in the negative territory.
- February 22, 2024 Former Prime Minister Thaksin Shinawatra could possibly be able to go back to his house to serve the remaining 6-months of his 1-year 'jail' term after having been in hospital since he arrived in Bangkok from his 15-year exile on August 22, 2023.
