## **Thai Enquirer News Summary**

### **Economic News**

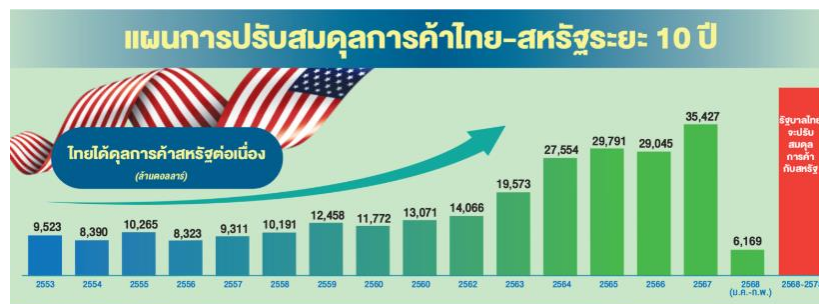
- Prime Minister Paetongtarn Shinawatra said after a meeting with economic agencies that she has assigned Deputy Prime Minister and Finance Minister Pichai Chunhavajira to lead trade negotiations with the United States in response to the recent 36% U.S. tariff increase on Thai imports. The U.S. has already acknowledged the Thai request and will schedule a meeting.



- Pichai noted that the issue won't be easily resolved but said the country needs a “win-win” solution that benefits both countries. The situation is also an opportunity to upgrade Thailand's production and trade system.
  - ❖ He will work with Commerce Minister Pichai Nariphaphan and Permanent Secretary Vuttikrai Leeviraphan to prepare details for direct talks with the U.S. Trade Representative (USTR). The goal is not to cut U.S. tariffs but to reduce the trade imbalance. Thailand currently runs a trade surplus with the U.S. of around USD 46 billion per year, and the government expects it could take more than 10 years to rebalance.



- ❖ The 5 key proposals for the talks are:
  - Increase imports from the U.S. – Focus on products Thailand needs, such as agricultural goods and energy, which are cheaper in the U.S.
  - Reduce or remove tariffs on some U.S. goods – Target over 100 items that currently generate low tax revenue in Thailand.
  - Remove non-tariff barriers – Make it easier for U.S. goods to enter the Thai market.
  - Tighten rules on product origin – Prevent misuse of Thailand as a false country of origin for goods exported to the U.S.
  - Encourage Thai investment in the U.S. – Support capable Thai companies, especially in agriculture and energy, to invest more in the U.S.

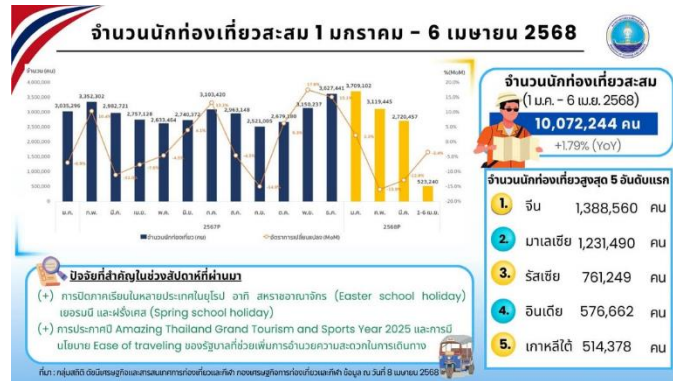


- The Federation of Thai Industries (FTI) has estimated that Thailand could suffer an estimated 900 billion Baht revenue loss from the US administration's imposition of 36% reciprocal tariffs on Thai exports to the US.
  - ❖ FTI President Kriangkrai Thiennukul said that the Thai industries expected to be hardest hit by the tax increases include automotive, food, plastic, chemical, steel, aluminium, textile, electronics and machinery.
  - ❖ The FTI has proposed that the government accelerates negotiations with the US administration, to cut import taxes for US products, such as maize, tuna fish and meat, and considers issuing certificates of origin for products manufactured in Thailand, such as hard discs and solar cells. The government should make serious efforts to tackle the problem of infringement of intellectual property and market dumping of cheap products into Thailand.

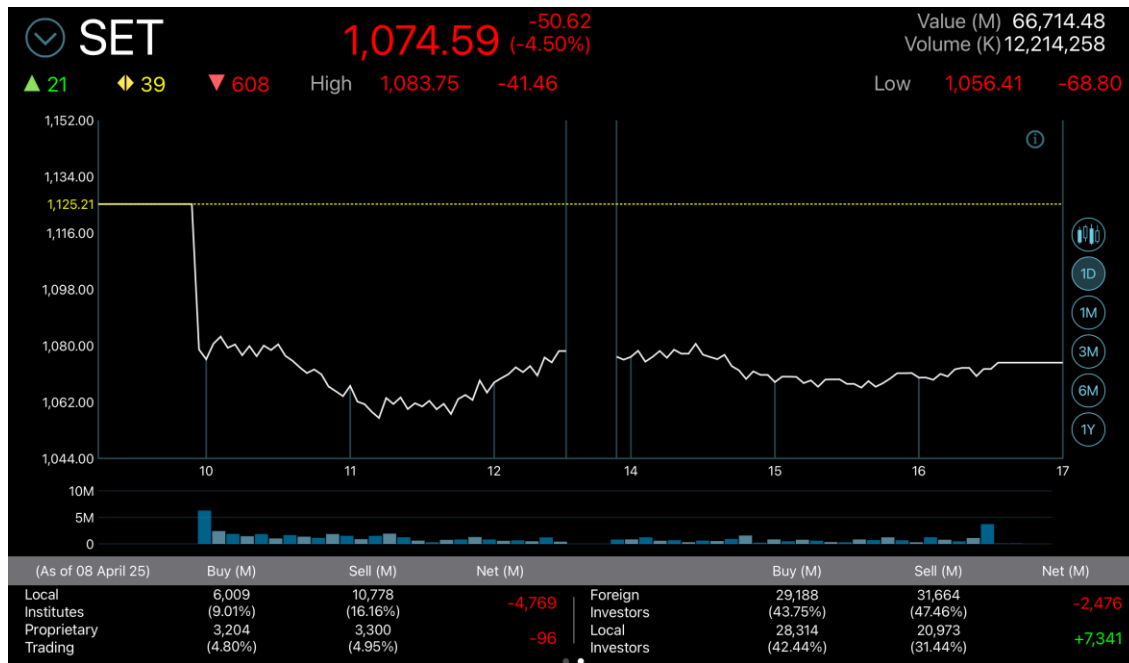


- The Ministry of Tourism has updated the latest tourism figures. From January 1 to April 6, 2025, Thailand welcomed over 10 million international tourists, generating 486.59 billion Baht in revenue.
  - ❖ The top five source countries were:
    - China            1,388,560 visitors
    - Malaysia       1,231,490
    - Russia           761,249
    - India             576,662
    - South Korea    514,378
  - ❖ During the past week (March 31 – April 6), many European countries began their school holidays, leading to a 9.97% increase in long-haul travelers.

- The number of tourists from the United Kingdom alone rose by more than 36.97%. As a result, the total number of international arrivals rose by 2.87% compared to the previous week. The number is expected to rise further in the coming week with the start of the Songkran Festival 2025.



- The Stock Exchange of Thailand (SET) index closed at 1,074.59 points yesterday, down 50.62 points or 4.50%, with a trading value of 66.71 billion Baht. The index dropped sharply below the 1,100-point level as it was the first trading day after a public holiday. Meanwhile, foreign markets had already reacted to the impact of Trump’s new tax policy on Monday.



- ❖ Temporary measures to reduce market volatility, such as banning short selling and adjusting ceiling and floor limits, only helped certain stocks and did not improve the overall market sentiment. Investors are still waiting for the government to negotiate with the U.S. on the tariff, but there has been no clear progress.
- ❖ The stocks with the highest trading values also saw significant price drops.

- KBANK fell by 13.50 Baht to 146.00 Baht with a trading value of 5.31 billion Baht.
- GULF dropped by 5.00 Baht to 40.00 Baht (4.50 billion Baht traded).
- SCB declined by 8.50 Baht to 114.00 Baht (3.96 billion Baht traded).
- ADVANC slipped by 1.00 Baht to 271.00 Baht (2.90 billion Baht traded).
- KTB lost 1.80 Baht to close at 20.90 Baht (2.69 billion Baht traded).

- Yesterday, the Securities and Exchange Commission (SEC) revealed a change in shareholding by Sarath Ratanavadi, CEO of Gulf Development Plc (GULF) and a major shareholder. He made several share purchases in early April.
  - On April 3, he bought 510,700 shares at 48.75 Baht each, totaling 24.89 million Baht. On April 4, he bought another 35 million shares at 46.49 Baht each, worth 1.63 billion Baht.

- ❖ On April 8, GULF shares dropped sharply by 11%, closing at 40 Baht with a trading value of 4.5 billion Baht. The day's highest price was 41.75 Baht, and the lowest was 38.50 Baht.



- Today, Bangchak and PTT Station will reduce retail prices of gasoline and gasohol by 0.50 Baht per liter, while diesel prices will remain the same.

- ❖ Bangchak is also offering a special promotion on its high-premium fuel. Prices for Hi Premium 97 and Hi Premium Diesel S will be reduced by 5 Baht per liter from April 11 to 13. The promotion is aimed at supporting safe driving during the Songkran holiday with high-quality fuel.





## **Political News**

- The Cabinet has agreed to defer the tabling of the bill to legalize casinos within entertainment complexes, which had been scheduled for introduction in the House of Representatives today.
  - ❖ Prime Minister Paetongtarn Shinawatra said coalition parties reached a consensus to prioritise other urgent agenda items, such as the issue of U.S. import tariffs. She emphasised that the bill has only been postponed, not withdrawn.
  - ❖ The postponement came after Senator Phisit Aphiwatthanaphong stated that around 100 of the 200 senators opposed the bill to legalize casinos within entertainment complexes and called for a national referendum on the matter.
  - ❖ It also followed the stance of the coalition Prachachart Party, which holds nine MPs and has indicated it may allow a free vote during the bill's first reading. Former party leader and current House Speaker Wan Muhamad Noor Matha said he opposes the bill, as gambling goes against Islamic principles.
  - ❖ Bhumjai Thai Party leader Anutin Charnvirakul earlier stated that his party no longer has reservations about the bill. However, earlier reports suggested that aside from Prachachart, other coalition parties are also not in support.



- On the same day, Prime Minister Paetongtarn chaired the Pheu Thai Party's general meeting. During her speech, she clarified that the plan for an entertainment complex had not been dropped, but the issue had been misrepresented.
  - ❖ She noted that countries like Singapore and Hong Kong have done similar projects—not with large-scale casinos, but smaller ones that still generate revenue.
  - ❖ She asked MPs and responsible ministers to help explain the idea further during the parliamentary recess.

- Also yesterday, former Prime Minister Thaksin Shinawatra visited the Pheu Thai Party headquarters, where party leaders and members took part in a Songkran tradition of pouring water to pay respect and ask for his blessing.



- ❖ Thaksin Shinawatra denied claims that he pressured coalition parties to support the draft bill to legalise casinos within entertainment complexes, saying there were no threats to remove any party from government.
- ❖ He explained that PM Paetongtarn decided to postpone the bill's first reading to prioritise urgent economic issues, especially U.S. tariff on Thai exports. He dismissed speculation that the government had pre-arranged business deals related to the bill, insisting the licensing process would be transparent and handled through open bidding.
- ❖ He said the bill aims to establish large entertainment complexes, with casinos occupying only a small portion. However, the opposition People's Party argued that casinos, while limited in space, could dominate revenue, as seen in similar projects abroad. On objections from coalition partners Bhumjai Thai and Ruam Thai Sang Chart, Thaksin said internal differences are normal, but the government has enough support to pass the bill and wants to avoid unnecessary tensions.
- ❖ If the bill cannot be passed during this government's term, it could continue under the next, and expressed confidence Pheu Thai would remain in power. He said delays may occur in the Senate, which has 180 days to consider the bill.





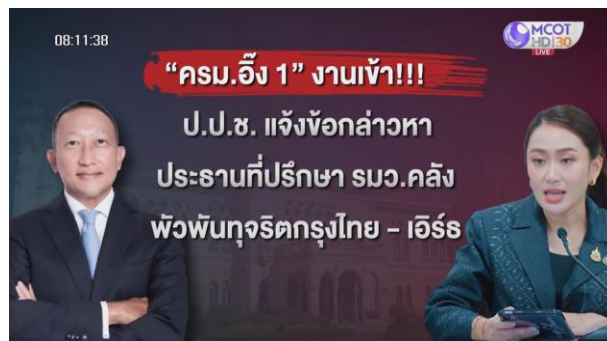
- Narumon Pinyosinwat, Minister of Agriculture and Cooperatives and leader of the Kla Tham Party, denied reports that Thaksin Shinawatra had instructed coalition MPs to support the draft Entertainment Complex Bill and threatened to remove those who did not.
  - ❖ She said she had not received any such message. However, she did speak with Capt. Thammanat Prompao, the party's chief advisor, and they agreed that the idea did not come from Thaksin, but was a suggestion made by one of the coalition parties.



- Main opposition People's Party leader Natthaphong Ruengpanyawut expressed support for the government's decision to delay the deliberation of the casino bill in the lower house. He also noted that if the bill is carefully studied and all stakeholders are considered, they might even support it, as it could help mitigate the problem of illegal gambling dens.
  - ❖ The delay would allow more time for a thorough feasibility study of the proposed entertainment complexes and to assess the social impacts, such as gambling addiction and concerns about transnational criminal groups potentially using the casinos for money laundering. The delay would also provide the government with more time to address objections and recommendations from the public and opposing groups.
  - ❖ Natthaphong agreed that other urgent issues, such as the U.S. tariffs on Thai goods, need to be clarified, especially regarding the government's plans to address the tariff hike. However, he called on the government to clarify the status of the amnesty bill, which was postponed to prioritize the casino bill. He questioned whether the amnesty bill would be discussed during the current parliamentary session, which ends on April 10.



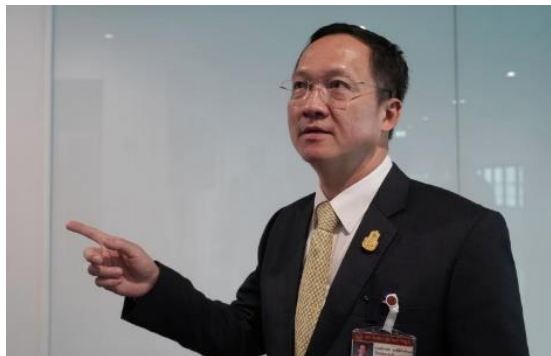
- What goes around, comes around
  - ❖ People’s Party (the successor to Move Forward party) is witnessing its own words boomerang.
  - ❖ The party under Move Forward Party banner had professed the opening up of the ‘Entertainment Complex’ during the debate in the parliament.
  - ❖ Pakornwut Udompipatskul, a party-list MP of People’s party, had in the parliament debated how it would be beneficial to Thailand to have ‘Entertainment Complex’

- On April 8 at 8:00 PM, the Senate held a meeting to discuss three motions related to the Entertainment Complex Business. During the debate, most senators called on the government to reconsider its policy, suggesting that if such a project were to proceed, it should include public hearings as well as potentially holding a referendum.
  - ❖ After a three-hour debate, the meeting formed a 35-member committee, including 12 external members. The committee was tasked with studying the issue over a period of 180 days. The meeting was adjourned at 11:05 PM.
- Media reports are suggesting that another headwind is approaching PM Paetongtarn, although it may not be that much of a headwind as PM Paetongtarn is not directly involved.
  - ❖ Vorapak Tanyawong, former President of Krung Thai Bank Plc (KTB), has been under investigation by the National Anti-Corruption Commission (NACC). Vorapak was also heading JP Morgan in Thailand and former executive at Finansa Syrus Securities Plc.
  - ❖ He is currently heading the advisory council of Deputy Prime Minister and Finance Minister Pichai Chunhavajira.



- Yesterday evening, Prime Minister Paetongtarn and her spouse presided over an event in honor of Air Force Day 2025, held at the Navaminda Kasatriyadhiraj Royal Thai Air Force Academy.



- Akkaradej Wongpitakroj, MP for Ratchaburi from the Ruam Thai Sang Chart Party and a member of the government whip, said that the government coalition will meet on April 9 at 9:00 AM to discuss the direction of the parliamentary session scheduled for April 9-10.
  - ❖ This follows an agreement among coalition parties to postpone the debate on the draft Entertainment Complex bill. Instead, the agenda will include the draft bills on promoting peaceful society and on amnesty — a total of four bills.
  - ❖ The party has confirmed its stance that it will not support any amnesty bill that includes offenses under Section 112 of the Criminal Code. This applies to both the bill proposed by Chaithawat Tulathon, former MP from the Move Forward Party, and the one proposed by civil society groups.



- The Phitsanulok Provincial Court has denied bail for Paul Chambers, an American academic and adviser on international affairs at Naresuan University, who has been accused by the 3rd Army Region of lèse-majesté and violating the Computer Crime Act.
  - ❖ An arrest warrant was issued by the court, and Dr. Chambers appeared at the Phitsanulok Police Station today to acknowledge the charges. No summons had been issued prior to the arrest warrant. Chambers, who holds a Ph.D. in political science from Northern Illinois University, is known for his research on civil-

military relations in Southeast Asia. He currently teaches at the Center of ASEAN Community Studies, Faculty of Social Sciences, Naresuan University.

### **Earthquake Tragedy**

- Prime Minister Paetongtarn Shinawatra has given the agencies concerned 90 days to provide a definite answer as to how the State Audit Office (SAO) building collapsed while under construction, after a devastating earthquake hit Myanmar on March 28th.
  - ❖ The prime minister was briefed yesterday, regarding the investigation into the collapse, by Interior Minister Anutin Charnvirakul, Minister of Higher Education, Science, Research and Innovations Supamas Isarabhakdi and Pongnara Yenying, director-general of the Department of Public Works and Town and Country Planning.



- Chinese steel manufacturer Xin Ke Yuan Steel has announced the postponement of its upcoming press conference concerning steel quality, opting to await clarification from the Industry Ministry on the same matter.
  - ❖ Previously, board directors Chen Jianqi and Somphan Pankaew stated on Sunday that the company intended to hold a press conference on the issue at the Rama Gardens Hotel in Bangkok on April 9.

- ❖ However, the Industry Ministry subsequently announced it would be holding its own press conference on the same topic at its headquarters in Bangkok's Ratchathewi district on Thursday, April 10. The ministry's briefing will also address long-term measures to ensure the quality of construction materials and to bolster public confidence in construction safety.
- The Ministry of Commerce has found evidence suggesting that some Thai shareholders of China Railway Number 10 are acting as nominees, said Deputy Minister Napintorn Srisunpang.
  - ❖ The company is part of the joint venture that built the collapsed State Audit Office building. These shareholders lack the financial capacity to make such a large investment, and the evidence has been submitted to the Department of Special Investigation (DSI). Additionally, the Ministry of Commerce is investigating 13 other companies that may be linked to China Railway Number 10.



### **General News**

- Government spokesman Jirayu Huangsub said that Prime Minister Paetongtarn Shinawatra filed a police complaint after an alleged conman falsely claimed a connection with her to deceive a well-known TV actress, Rinyarat Watcharojsiri. Paetongtarn and her media team reported to police that the individual known as “High-society member Hot” was not among her advisors.



- ❖ Hot allegedly led Rinyarat to believe he intended to marry her, and reportedly defrauded her of an undisclosed sum of money. She later discovered that he was already legally married to another woman. After Rinyarat filed a complaint, police arrested the suspect. However, he sustained injuries after jumping from the third floor of the Khok Kham Police Station and is now being treated in hospital.
- ❖ Jirayu clarified that Paetongtarn has only 3 official advisors: himself; Thirapong Wongsiwawilas, former Secretary-General of the PM’s Office and Nattawut Saikua, a prominent red-shirt leader.



- The Thai Cabinet has approved a proposal to submit “Wat Arun Ratchawararam Prang: Identity of Rattanakosin” for inclusion on UNESCO’s Tentative List of World Heritage Sites. The submission will be sent to the World Heritage Centre in Paris, France by the end of April.
  - ❖ Culture Minister Sudawan Wangsuphakitkosol stated that the Wat Arun Prang meets UNESCO World Heritage criteria 1 and 2, being a masterpiece of Rattanakosin-era architecture and art influenced by Ayutthaya-period prangs but developed into a distinctive style unique to the Rattanakosin period.
  - ❖ The next step is to submit documentation requesting inclusion on the Tentative List on behalf of Thailand to the World Heritage Centre in Paris this April. The nomination will then be presented and potentially approved at the World Heritage Committee’s regular session between June and July this year.
